Employment Ads

"Help Wanted" job listings are posted on the public side of vhba.com — this allows students and professionals who may not currently be members respond to the posting

Items for Sale

"For Sale" ads are posted on the Members' Only side of vhba.com to promote doing business with members and to prevent the association web site from becoming a perceived commercial endeavor

Ad submissions

Copy may be submitted via email, fax or U.S. mail, with the preferred method being email. Submissions are reviewed by VHBA prior to posting, and if content is questionable, the member will be contacted for clarification. Members agree that submitted listings will not include information that:

- is false, deceptive, misleading, deceitful, inaccurate, or constitutes "bait and switch";
- infringes any patent, trademark, trade secret, copyright or other proprietary rights of any party, or content that you do not have a right to make available under any law or under contractual or fiduciary relationships;
- advertises any illegal service or the sale of any items the sale of which is prohibited or restricted by any applicable law, including without limitation items the sale of which is prohibited or regulated by Wisconsin law.

Submitted and approved copy will be posted within 72 hours of receipt of listing and payment. Listings must include a contact telephone number of the employer/seller and a contact email address is highly encouraged. (To protect member email addresses, VHBA will include a hyperlink to the email address but not the actual address.)
