RELEASE FORM

To participate in this ride, this form MUST be completed and returned.

The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to ride in the Motorcycle Ride for Charity (hereinafter "EVENT") sponsored and/or conducted by the Valley Home Builders Association, Brown County Home Builders Association and the Wisconsin Builders Foundation and their respective officers, directors, trustees, employees and agents (hereinafter "RELEASED PARTIES) releases and holds harmless the RELEASED PARTIES from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the RELEASED PARTIES in any way resulting from, or in connection with, the performance of their duties and my participation in the EVENT.

This Release extends to any and all claims I have or later may have against the RELEASED PARTIES resulting from or arising out of their performance of their duties, whether or not such claims result from the negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES with respect to the EVENT, or with respect to the conditions, qualifications, instructions and rules or procedures under which the EVENT is conducted, or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES FOR ANY INJURY RESULTING TO MYSELF OR MY PERSONAL PROPERTY ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF THEIR DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENT.

I am voluntarily participating in the EVENT. I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the EVENT and negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES in performing their duties.

I further agree to waive all benefits flowing from any state statute which would negate or limit the scope of this Release and Indemnification.

If a driver in the EVENT, I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I agree not to consume alcohol or other controlled substances during the EVENT.

I also agree to follow standard group riding rules during the EVENT, including, but not limited to, the use of hand signals and staggered positioning.

By signing this Release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the Released Parties.
